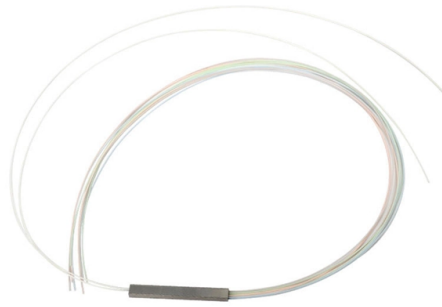


Safe distance between communication optical cables and 110KV



Overview

A safe distance must be maintained from power lines of different voltage levels: greater than 1.5m for 110KV, and greater than 3.
